Management is also responsible for implementing and maintaining a system of internal controls to provide reasonable assurance that reliable financial information is produced.



Their examination includes a review and evaluation of the Thompson Regional Hospital District's system of internal control and appropriate tests and procedures to provide reasonable assurance that the financial statements are presented fairly. The external auditors have full and free access to the Audit Committee of the Board and meet with it on a regular basis.


