UTILITY BILLING INFORMATION:

TNRD Utility customers can now pay their bill by online banking through most financial institutions. (Please select **Thompson-Nicola Regional District Utilities** as the payee). Customers can also pay by cheque, mailed to the TNRD Civic Building, or in-person at the TNRD Civic Building by Debit, cash or cheque.

IMPORTANT:

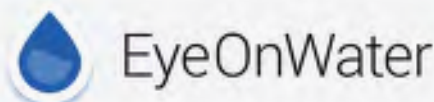
Quarterly billing is now required to go to the landowner of the property. This means that tenants will no longer receive these bills in their mail. (Per Bylaw 2757).

TO CALCULATE YOUR UTILITY BILL:

- Look at your Service code on your mock bill - that refers to the meter line size installed into your house.
- Look at the current read 1883 m3 (June 30th read) and your Previous read 1539 m3 (March 31)
- Total water Consumption for the March 31 to June 30 quarter is 1883 - 1539 = 344m3
- The base rate for a 19mm water services is \$133.00
- If the customer uses 0- 285 m3 of water, each m3 is \$0.62. Over 285 m3 is \$0.62/m3

Example of Calculation (Please refer your mock bill for your personal consumption information)

Base rate \$133.00
344m³ * \$0.62 = \$213.28
Total Mock Billing \$346.28

FALL 2022

Construction has been completed of the new chlorination system, and is operational as of July 2022. This upgrade prevents growth of bacteria and inactivates viruses in water that can cause serious illness if consumed. The Blue River Community Water System was the only

TNRD water system without a disinfection process, and the chlorination system will maintain water quality and prevent waterborne illnesses. Construction of a chlorination system is required by Interior Health Authority for all water systems.
